

Welcome to Savvy Eyes, and thank you for entrusting us with your eye care needs!

Attached are some documents that all new patients need to complete. If there are multiple members of your family coming in at the same time, we ask that you fill out one packet for each patient. We ask that you fill these forms out ahead of time so we can serve you more efficiently in the office.

Pages 1 & 2 include basic demographic information, insurance information, personal and family eye health history, and personal and family general health history. If you are currently taking several medications, you can attach a copy of your medication list rather than write them all on this form.

Page 3 is an acknowledgement of receiving a copy of our privacy practices policy. The actual policy should be included in this email as a separate attachment. Please sign and date this form.

Page 4 is a signature page acknowledging that you will be using insurance for any part of your exam or order for glasses or contact lenses. If you're using Medicare as your insurance, please sign the bottom paragraph. If you're using any other insurance company, please sign only the top paragraph.

Page 5 explains our contact lens evaluation policy. Please sign and date only if you will be needing a new or updated contact lens prescription.

Page 6, the last page, is a consent for our iWellness scan which takes pictures of the retina and does an ultrasound of the layers of the retina. This is non-invasive, takes less than two minutes, and gives the doctor a better view of the health of your eyes. Dr. Manos recommends this to ALL of our patients, including children, but particularly those with high blood pressure or diabetes or anyone with a family history of macular degeneration, glaucoma, or any other eye disease. Dr. Manos will go over the results of this test with you in the exam room. It's just a \$39 copay on your insurance. Please sign & date the appropriate line.

Medicare Advance Beneficiary Notice (ABN)

Medicare is your primary health insurance, and for your convenience, our office bills Medicare for your examination. Medicare then reviews all submitted claims, and if approved, reimburses 80% of the approved amount. The remaining 20% (the co-payment) is your responsibility as the Medicare beneficiary.

The Medicare yearly deductible for 2026 is \$283.00. If our office is the first to submit Medicare claims for you each year, Medicare will notify us that you have not yet met your deductible for that year. Medicare will not pay for your allowable fees until the deductible is met.

Medicare does not pay for the refractive services, which is the part of your eye exam that determines your prescription. **The charge for your refraction is \$45.00 and is your responsibility.**

Medicare only pays for the covered items and services when Medicare rules are met. The fact that Medicare may not pay for a particular item or service does not mean that you should not receive it. There is a good reason your doctor recommended it.

The purpose of this form is to help you make an informed choice about whether or not you want to receive these items or services, knowing that you may have to pay for them yourself.

1. Read this entire notice carefully.
2. Ask us to explain if you don't understand why Medicare probably won't pay.

I understand that Medicare will not decide whether to pay unless I receive these items or services. Please submit my claim to Medicare. I understand that you may bill me for items or services and that I may have to pay the bill while Medicare is making its decision. If Medicare does pay, you will refund any payments I make to you that are due to me. If Medicare denies payment, I agree to be personally and fully responsible for payments, either out-of-pocket or through any other insurance that I have. I understand I can appeal Medicare's decision.

Contact Lens Evaluation Policy

A contact lens evaluation is not included in a routine vision examination. The cost of the contact lens evaluation includes trial contact lenses, as well as the necessary follow-ups to ensure the proper fit and the best vision in your contact lenses. The full evaluation fee will be the patient's responsibility, unless discounted by his/her insurance. Our evaluation fees are as follows:

Standard Evaluation: \$75.00

(Spherical Lens)

Toric Evaluation: \$95.00

(Astigmatism Lens)

Multifocal/Specialty Evaluation: \$125.00

(Multifocal, Monovision, RGP, SynergEyes Hybrid Lens)

*Fees for complex contact lens evaluations are higher due to requiring more doctor consultation time, follow-ups, and additional contact lens trials.

iWellness Exam

In an effort to provide a more thorough eye exam, Savvy Eyes has incorporated the iWellness Exam™ SD-OCT as part of our comprehensive eye exam. Like an MRI of the eye, but taking only seconds to perform, the iWellness Exam™ provides high definition cross sections of your retina and optic nerve which can reveal signs of disease in exquisite detail that are invisible to traditional examination methods.

This unique technology can help detect potentially vision threatening and systemic diseases in their very early stages. Such diseases include **glaucoma, macular degeneration, cancer in the eye, signs of diabetes and high blood pressure in the eye, and congenital conditions which can cause blindness in children.** It will also provide Dr. Manos with a permanent baseline record of your retinal examination for comparison during future exams.

As part of your pre-examination work-up, our technician will perform this test which Dr. Manos will review with you during your examination today. **There is a \$39 copay for this noninvasive test.** This cost will be added into the price of your visit today. Any questions you have about these tests can be discussed during your examination.




